A RESOLUTION AUTHORIZING THE TRANSFER OF THE SATELLITE OFFICE OF THE HOUSING AND LAND USE REGULATORY BOARD (HLURB) FROM THE BACOR COLISEUM TO THE NATIONAL AGENCIES CENTER (NAC) BUILDING AT THE BACOR GOVERNMENT CENTER AT BARANGAY BAYANAN, BACOR CITY, CAVITE.

Bernardo, its Chief Operating Officer regarding the establishment of a satellite office of the HLURB at the Bacoor Coliseum, Camella Springville Subdivision, Molino III, City of Bacoor pending the completion of the Bacoor Government Center (BGC) situated at Brgy. Bayanan, Bacoor City.

WHEREAS, the Bacoor Government Center is now fully operational as of this writing.

WHEREAS, transferring the said satellite office to the BGC will provide convenience to the general public as part of the one stop shop program of the city government.

NOW THEREFORE, upon unanimous motion of the council, in joint session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to pass a resolution authorizing the transfer of the satellite office of the Housing and Land Use Regulatory Board (HLURB) from the Bacoor Coliseum to the National Agencies Center (NAC) Building at the Bacoor Government Center at Barangay Bayanan, Bacoor City, Cavite.

RESOLVED LASTLY, to furnish the Housing and Land Use Regulatory Board (HLURB) and other government offices concerned with copies of this resolution.
