A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH THE DEPARTMENT OF SCIENCE AND TECHNOLOGY (DOST) IV-A REGARDING THE ESTABLISHMENT OF A WASTE WATER TESTING LABORATORY IN THE CITY OF BACOR.

**WHEREAS**, the health facility of the City Government of Bacoor is duly authorized by the Department of Health (DOH) to implement the Implementing Rules and Regulations (IRR) of Chapter II "Water Supply" of the Code of Sanitation of the Philippines.

**WHEREAS**, the City Government of Bacoor is in need of a DOH accredited laboratory that can monitor the quality of all water suppliers and refilling station in the city for a reasonable price.

**WHEREAS**, the Cavite Water and Waste Water Testing Laboratory (CWWTL) of the DOST IV-A with DOH, ISO/IEC 17025 accreditation and DENR recognition is capable of monitoring bacteriological and physico-chemical quality of water.

**NOW THEREFORE**, upon motion of Councilor Roberto R. Javier, and unanimously seconded by the City Council, in joint session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve a resolution authorizing the City Mayor to sign a Memorandum of Agreement the Department of Science and Technology (DOST) IV-A regarding the establishment of a waste water testing laboratory in the City of Bacoor.

**RESOLVED LASTLY**, to furnish the Department Science and Technology (DOST) IV-A and Department of Environment and Natural Resources (DENR) and other government agencies concerned with copies of this resolution.
