A RESOLUTION AMENDING CITY RESOLUTION NO. CR 2015-145 ENTITLED "A RESOLUTION APPROVING THE REQUEST FOR AN ELECTRIC GENERATOR UNIT TO BE TEMPORARILY INSTALLED AT THE BACOOR PUBLIC MARKET TO BE USED BY THE 100 STALLS WITHOUT ELECTRICITY SERVICE CAUSING RISK TO ALL MARKET VENDORS, STALL HOLDERS, BUYERS AND COMMUNITY AS WELL".

WHEREAS, the Sangguniang Panlungsod previously adopted City Resolution No. CR 2015-145, Series of 2015 on September 1, 2015.

WHEREAS, there is a need to amend the title and declaration clause thereof so as not to limit the number of it beneficiaries.

WHEREAS, the title of the said Resolution is henceforth amended and shall read as follows: "A resolution authorizing the temporary installation of an electric generator unit at the Bacoor Public Market to be used by all stall owners currently or may hereafter be without electricity service in order to abate the possible risk of food spoilage, among others, to all market vendors, stall holders, buyers and community as well."

WHEREAS, the declaration clause of the said Resolution is henceforth amended and shall read as follows: "NOW THEREFORE, upon motion of Councilor Rowena Bautista-Mendiola, duly seconded by Councilor Reynaldo Palabrica, in joint session assembled, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve a resolution authorizing the temporary installation of an electric generator unit at the Bacoor Public Market until electricity is restored to all stall owners that are now or may hereafter be without electricity services."

UNANIMOUSLY ADOPTED this 9<sup>th</sup> day of November 2015 at the City of Bacoor during the 114<sup>th</sup> regular session of the Sangguniang Panlungsod of the City of Bacoor.


