A RESOLUTION INTERPOSING NO OBJECTION TO THE ALTERATION OF THE SUBDIVISION PLAN OF LOT 3, BLOCK 5, PSD-04-001047 COVERED BY TCT NO. 057-2012030882 OWNED BY MS. NERISA OLLER AS REQUESTED BY NEW VALLEY PHASE I HOMEOWNERS ASSOCIATION, INC. IN RELATION TO ITS APPLICATION FOR INCLUSION IN THE COMMUNITY MORTGAGE PROGRAM (CMP) FOR NEW VALLEY PHASE I LOCATED AT MAGDIWANG PHASE II, MOLINO III, CITY OF BACOR, CAVITE.
