A RESOLUTION AUTHORIZING HON. ACTING MAYOR CATHERINE S. EVARISTO, ACTING CITY DISASTER RISK REDUCTION MANAGEMENT COUNCIL (CDRRMC) CHAIRPERSON, TO DISBURSE THE AMOUNT OF FIVE MILLION PESOS (P5,000,000.00) FROM THE LOCAL DISASTER RISK REDUCTION MANAGEMENT FUND.

WHEREAS, based on initial assessment of the City Social welfare and Development Office, there are at least 30 barangays that were affected by flash flooding across the city;

WHEREAS, there is a need to provide augmentation to the affected families in various barangays in the city;

WHEREAS, there is a need to immediately implement clearing operations of debris from rivers and creeks in various areas of the city;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Bacoor, Province of Cavite, in regular session duly assembled to authorize Hon. Acting Mayor Catherine S. Evaristo, Acting City Disaster Risk Reduction Management Council (CDRRMC) Chairperson to disburse the amount of Five Million Pesos (Php5,000,000.00) from the Local Disaster Risk Reduction Management Fund.
